

PRIVACY POLICY

This Policy is fulfilled in accordance to Section 13 of Legislative Decree no. 196 of 30/06/2003 and the principles fixed by the Italian Privacy Authority and the corresponding European Authorities.

This Policy is drafted also in accordance with the Recommendation no. 2/2001 by the European Authorities for the protection of personal data, associated in the Group instituted by art. 29 of Directive n. 95/46/EC, adopted on May 17, 2001 to establish minimum requirements for collecting personal data online and, in particular, the manner, timing and nature of the information that data controllers must supply users when they connect to web pages, regardless of the purpose of connecting.

The Information is released only for the site www.veronikiholding.com, and not for other Web sites accessed via links.

Veroniki Holding S.p.A. (Data Controller, hereinafter as "the Company") announces that while browsing starting from <http://www.veronikiholding.com>, home page of the Official site of the Company, are automatically collected system logs relating directly or indirectly to the navigator, in particular:

- the IP address;
- the page of origin;
- the type of browser and operating system used by the navigator.

These data are used only for purposes of monitoring activities on the company website. Of course, except the communication and dissemination of data as required by law, police, judicial authorities, the intelligence and security agencies or other public entities for purposes of defense or state security or prevention, detection or suppression of crime.

The company ensures:

- not to collect the following navigation data:
 - domain names of computers used by users who connect to the site;
 - URI (Uniform Resource Identifier) of requested resources;
 - time of the request;
 - method used to submit the request to the server;
 - size of the response file;
 - Code indicating the type of response from the server (successful, error, etc.);
 - other parameters related to the operating system and computer environment;

The personal data provided by users who specifically request dispatch of informative material is used only to satisfy the request and will be disclosed only to third parties involved in processing the application itself.

The optional, explicit and voluntary e-mail addresses listed on this website implies the subsequent acquisition of the sender, necessary to answer the e-mail communications, and any other personal data included in the e-mail.

Specific privacy information (Art. 13, Leg. 196/2003) are displayed in the web pages containing personal data requests.

The web site is protected by special security measures, in line with technological progress and the development of cyber risks; the specific security measures taken to manage the website are contained in the "Security Policy" Veroniki Group.

Please note that, although the company will do everything reasonably possible to protect the site and any personal data provided by the navigators, the current state of technology is not able to entirely avoid the risk of navigational safety or transmission of data by e-mail: no internet transmission or e-mail can be said perfectly secure or error free.
